## **ADDERLEY PARISH COUNCIL**

Minutes of the Adderley Parish Council meeting held at The Village Hall, Adderley on Wednesday 10<sup>th</sup> April 2019 at 7.30pm

- 1. Welcome / Present / Apologises Councillors present as listed above.
- 2. Declarations of Interest None
- **3. Public Session** There was one member of the public present who, being a member of the speed concerns committee, spoke to the Council about the forthcoming meeting between this committee and representatives of WSP, the consultants to Shropshire Highways, regarding the A529 work.
- 4. Approval of the Minutes of the Parish Council meeting on 27<sup>th</sup> February and the Extraordinary Meeting on 27<sup>th</sup> March 2019 Prior to the meeting the Councillors had received copies of these minutes and it was resolved by the Council that both were a true and accurate record of proceedings.
- 5. Clerk's update regarding on-going matters:

The following updates were advised to the Council:

- a. A quote had now been received relating to tarmacing the little strip of land along the A529 which was £4,817 plus vat, which was more than the Council envisaged. This area will be sprayed over the next couple of weeks with weed killer after which the Council decided to review how it looked.
- b. The Clerk has obtained confirmation from Shropshire Fire and Rescue that the new fence erected on the corner of Rectory Lane and A529 has not impeded the water hydrants but Shropshire Highways have not confirmed the position regarding the fingerpost, which is now inside the fence, the Clerk will chase.
- c. The Clerk showed the Council various types of sign that could be used to point to the church and, after discussion, it was agreed that Cllr Coulon would walk around the village and circulate a proposal of how many and what type of signs could be used.
- d. The date of the Annual Parish Meeting was agreed, Wednesday 24<sup>th</sup> April 2019, and Cllr Coulon will chase the other groups in the village to see if they would like to do a report for this meeting.
- e. The Clerk reported that she had not heard from Shropshire Highways regarding the Visibility Mirror application and would chase this.
- Report from Unitary Councillor Unfortunately Cllr Wynn was unable to attend this meeting.
- 7. Report from Committees by Adderley Parish Council Representatives Cllrs Nash and Mycock reported from the SALC North meeting:
  - a. HS2 Impact this will affect Woore and the area around it as it is estimated that 200 lorries will be travelling between the Barhill tunnel and junction 15 of M6. Junctions on A51 and A53 will altered to accommodate the lorries and there will be no on-street parking in Woore during this time. There will also be an impact on the national grid relating to the tunnel borer.
  - b. Cllr Nutting, leader of Shropshire Council, said in the course of the SALC meeting that he was actively looking at moving the Market Drayton Town Council into the surrounding parishes. It was suggested, at this Adderley Parish Council meeting, that this statement should be followed up in conjunction with the adjoining parishes, all agreed.

Cllrs Nash and Coulon reported on the recent Place Plan Meeting:

c. At this meeting the existing draft Place Plan for the Market Drayton Area had been discussed in detail and Cllr Nash highlighted the parts that directly effected Adderley. It was proposed, and unanimously agreed to include: signposting a safe route to the church; improvement of the strip of land alongside the A529 (in consultation with the A529 upgrade) – the Clerk will email Lucy Roberts regarding these amendments.
