

ADDERLEY PARISH COUNCIL

Minutes of the Extraordinary meeting of Adderley Parish Council on 31st August 2022
held at Adderley Village Hall and starting at 6.00 pm

1. **Welcome / Present / Apologies** – Councillors present as listed above.
2. **Declarations of Interest** – Cllr Coulon declared an interest in item 5.
3. **Public Session** – There was one member of the public present who handed a statement to the Cllrs regarding his formal complaint, signed by the residents of 6 properties in Green Bank, along with photos of the gutter in places along Green Bank. The member of the public also advised the Council that some residents had volunteered to form working parties to clean up the gutters. The Council unanimously supported this initiative.
4. **Planning** – The following Planning Applications were considered and *comments agreed*:

22/03791/ADV - Erect and display 3No sponsorship signs placed on A53/Blandford Way Roundabout and 5No sponsorship signs on the A53/A529 Adderley Road roundabout - A53/Blandford Way Roundabout and A53/A529 Adderley Road Roundabout., Market Drayton, Shropshire – *The Council discussed whether any income generated from this scheme would benefit Shropshire Highways but this was unknown at this time. The Council agreed to object to this planning application as it may be a distraction to road users.*

5. **Expenditure** – For the Council to accept and approve the below detailed expenditure

It was resolved by the Council that these expenses were paid.

6. **Complaint Procedure** - Prior to the meeting the Clerk had circulated a proposed Complaints Procedure based on the latest information from NALC. The Council agreed to adopt this procedure and the Clerk will update the Policy section of the Parish website.
7. **Shropshire Highways email regarding A529** – Prior to the meeting the Clerk had circulated this email and the Council discussed the speed limits within this document which the Council understands will be used as the basis of a consultation to the residents of Adderley. The Council agreed to support the proposed speed limits although Cllr Shepley suggested that the 20-mph limit outside the school may be more effective if it was only during term time. The Clerk will pass on the Council's comments to Shropshire Highways.
8. **The Queen's Green Canopy** – Cllr Nash advised that 15 residents had expressed an interest in receiving a small fruit tree as part of this initiative and the Council agreed that the Clerk should source these trees, locally if possible, with a maximum cost of £15 per tree. It was further agreed that the fruit trees should be given out at the Coffee Morning at the end of September.
Prior to the meeting the Clerk had circulated information regarding Shropshire Council's Tree Scheme and the Council agreed that a wild cherry tree should be applied for as the Parish Council's Commemorative Tree for the Queen's Green Canopy.


